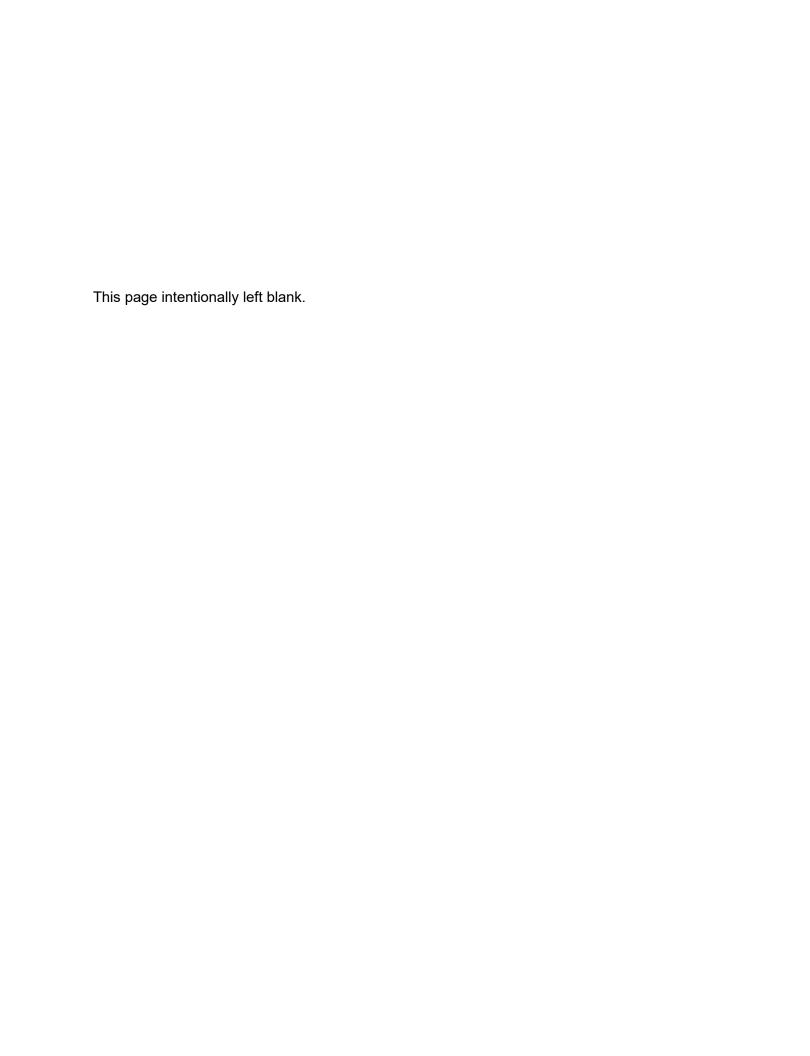
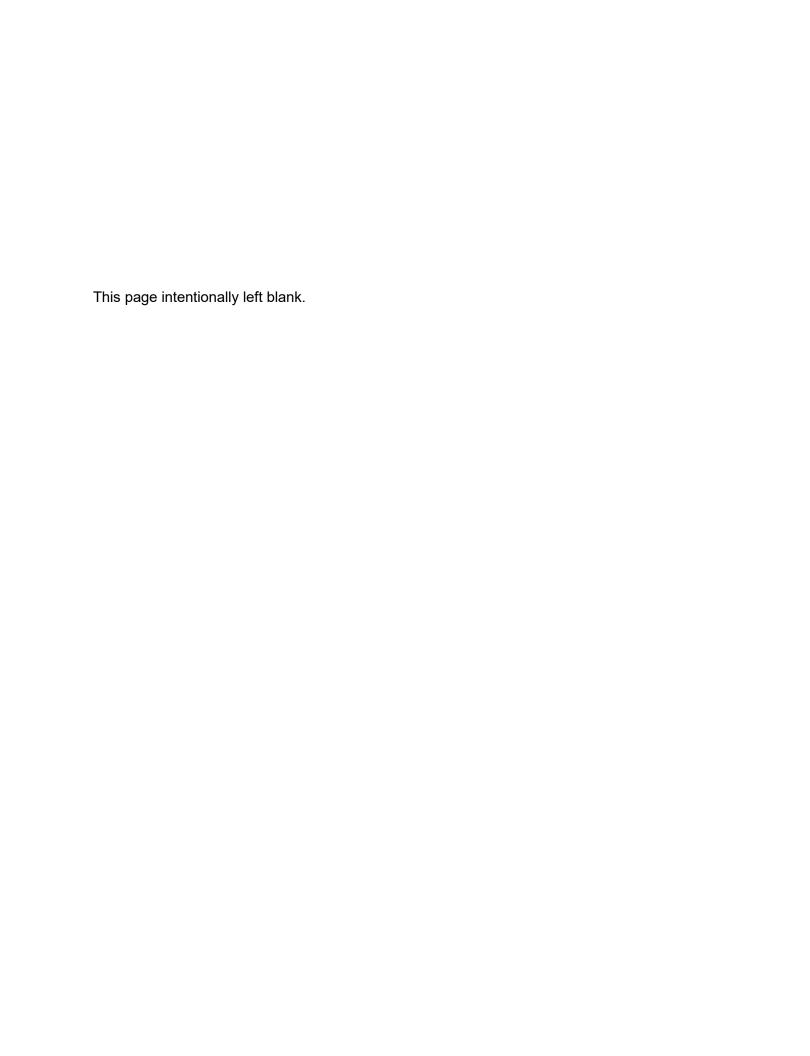

The County of Imperial (County) has initiated environmental review under the California Environmental Quality Act (CEQA) for the McCabe Ranch II Tract Map 994 (TR00094) and McCabe Ranch II Specific Plan Amendment #24-0001 for an approximately 351.2-acre portion of the 468-acre McCabe Ranch II Specific Plan Area.

PROJECT BACKGROUND: In December 2010, the Imperial County Board of Supervisors (Board) approved the McCabe Ranch II Specific Plan (SP07-004), which established a framework for development within the Specific Plan Area. The Board also certified the Final Environmental Impact Report for the McCabe Ranch II Specific Plan (SCH No. 2008111037) (2010 Final EIR) and adopted the Mitigation and Monitoring Program and CEQA Findings.


Figure 2 – Project Site

**PROJECT LOCATION**. The McCabe Ranch II Specific Plan Area is generally located north of the Community of Heber and south of the City of El Centro, in the County of Imperial, California (**see Figures 1 and 2**). The McCabe Ranch II Tract Map 994 Project site is comprised of four (4) parcels; County of Imperial Assessor Parcel Numbers (APNs) 054-130-072, -076, -077, and -078 and is located in Section 20, Range 14 East, Township 16 South within the U.S. Geological Survey (USGS) Heber, California 7.5-minute topographic map.

PROPOSED PROJECT. McCabe Ranch Realty, LLC (Applicant) is seeking to process a Subdivision Tentative Map, referred to as the McCabe Ranch II Tract Map 994, for an approximately 351.2-acre portion of the 468-acre McCabe Ranch II Specific Plan Area to accommodate the phased development of 1,610 single- and multiple-family residential units, an elementary school site, and associated improvements to roadways and public utilities. Development of the McCabe Ranch II Tract Map 994 is proposed to occur in phases (Phase 1A, 1B, 2A, 2B, 3A, 3B, 3C) over a 14-year period between 2025 and 2039. Development of the Specific Plan area outside of Tract Map 994 (i.e. Phase 4), may develop before, concurrent with, or after the Tract Map 994. An amendment to the McCabe Ranch II Specific Plan and annexation to the Heber Public Utilities District will be required. The Applicant may also enter into a Development Agreement with the County.

The 90-day period consultation request period ended on April 19, 2010 and no consultation requests were received.

In accordance with Assembly Bill 52 (AB 52) and Section 21080.3.1(d) of the California Public Resources Code (PRC), we are responding to your request to be notified of projects in our jurisdiction that will be reviewed under CEQA. Your name was provided to us as the point of contact for your tribe. We are hereby notifying you of an opportunity to consult with the County regarding the potential for this project to impact Tribal Cultural Resources, as defined in Section 21074 of the PRC. The purposes of tribal consultation under AB 52 are to determine, as part of the CEQA review process, whether or not Tribal Cultural Resources are present within the project area, and if so, whether or not those resources will be significantly impacted by the project. If Tribal Cultural Resources may be significantly impacted, then consultation will also help to determine the most appropriate water to avoid or mitigate those impacts.

In accordance with Section 21080.3.1(d) of the PRC, you have 30 days from the receipt of this letter to either request or decline consultation in writing for this project. 




Figure 2 – Project Site






















