Consideration of **Brown Act Resolution** to "Adopt resolution authorizing remote teleconference meetings in accordance with Assembly Bill 361."

(INFORMATIONAL ITEM) Assessment #21-0037: The project applicants, Hell's Kitchen Power Co. 1 LLC & Hell's Kitchen Lithium Co I LLC, Conditional Use Permit (s) #21-0020 & #21-0021, Variance(s) #21-0004 & #21-0005, proposes to construct and operate a 49.9 mega-watt (MW) geothermal turbine generator facility and construct and operate a Lithium & mineral extraction and processing facility. The project geothermal facility will consist of production and injection wells and well pads, geothermal pipelines, brine processing facility with brine pond, a 49.9 Mw net geothermal turbine generator facility, control buildings, administrative and warehouse buildings, an onsite substation and a 230 k-V gen-tie line to the IID interconnect station at Hudson Ranch. The project including Lithium and mineral extraction will be capable of producing commercial qualities of lithium hydroxide, silica, and bulk sulfide & polymetallic products. The project site is located approximately 3.6 miles west of the community of Niland on parcels 020-010-012 & 013, 020-070-029 & 020-070-060-000. The Parcels are zoned S-1 G (Geothermal) within a General Plan Agricultural Designation.
