

PUBLIC NOTICE

Pursuant to the requirements of the CALIFORNIA ENVIRONMENTAL QUALITY ACT (CEQA) and the County's "RULES AND REGULATIONS TO IMPLEMENT CEQA" the Imperial County Environmental Evaluation Committee will meet on **September 11, 2025** at **1:30 p.m.** in the Board of Supervisors Chambers, 940 Main Street, El Centro, to review the below-mentioned projects:

(Negative Declaration) Assessment #25-0009: Applicant: Omega Harvested Metallurgical proposes Conditional Use Permit #25-0003 to operate a battery recycling facility to operate in an existing 8,000 sq. ft. building located at 2255 Melon Road, in an unincorporated area of the County, adjacent to the City of Holtville. Property identified under Assessor's Parcel Number 045-570-088-000. The proposed operation will exclusively process inert, inactive lithium batteries that have been discharged at a facility in LA County. These batteries will be delivered to the site in Holtville by truck, Monday through Friday, with daily deliveries of approximately 40,000 lbs and a maximum of approximately 120,000 lbs. Deliveries are expected to occur around 11:00 am, while exports will take place around 9:00 am. A maximum of two trucks will transport the crushed materials from the site to San Diego for export to Japan. Crushed batteries will be stored on-site for no more than 48 hours. The facility's operating hours will be Monday through Friday, from 8:00 am to 5:00 pm approximately.
