VI. Public Hearings

1. Public hearing to consider compatibility of Cal 98 Holdings' requested Zone Change from A-2-U (General Agriculture in Urban Area) to M-1-U (Light Industrial in Urban Area) and Conditional Use Permit for a +/- 36.57 acres trucking and warehouse facility consisting of a 114,293 square foot warehouse with 832 trailer parking spaces, 20 truck parking spaces and 42 car parking spaces. The proposed project is within the Imperial County Airport Compatibility Plan C Zone (Common Traffic Pattern). The proposed project site is located at 15 SR-98 Calexico, CA 92231 on the southeast corner of the intersection of State Route 98 and Dogwood Road +/- .4 miles west of Calexico. Parcel centroid coordinates 115° 31' 51.69503" W, 32° 40' 37.12653"; Assessor's Parcel Numbers 058-180-001-000 (Supervisorial District #2) (ALUC 01-23) Planner II, 442-265-1736, extension 1756 or by email at dereknewland@co.imperial.ca.us].
