NOTICE OF ADOPTION OF ORDINANCE NO. 1445 AN ORDINANCE AMENDING CERTAIN CODIFIED ORDINANCES OF THE COUNTY OF IMPERIAL ENACTING TRAFFIC IMPACT FEES

NOTICE IS HEREBY GIVEN that the Board of Supervisors of Imperial County, after a properly noticed public hearing held on December 23, 2008, adopted Ordinance No.1445. This ordinance adopts a new Chapter 4.33 to Title 4 of the Revenue and Finance Code of the Codified Ordinances of the Imperial County (4.33.010 through 4.33.150). This ordinance enacts Imperial County policies requiring New Development in the county to supplement the fair share of traffic-related impact mitigation costs of public facilities, equipment, improvements and services necessitated by such new development and by establishing the associated funding source for those fair share costs. This ordinance also adopts the amount of fees for the Central Imperial County Traffic area. The Central Imperial County Traffic Area is defined as that area bounded by Aten Road to the south, Forrester Road to the west, Schartz Road to the north, and State Route 111 to the east.

The Traffic Impact Fee rates to be imposed for Central Imperial County Traffic Impact Fees are as follows:
