1.0 INTRODUCTION

1.1 Purpose

The purpose of this Phase I Environmental Site Assessment (ESA) is to identify potential environmental hazards associated with past and present activities on the subject sites or in the immediate site vicinity in general conformance to ASTM Standard E-1527-05 “*Standard Practice for Environmental Site Assessments: Phase I Environmental Site Assessment Process*”. No environmental assessment can completely eliminate the possibility of hazardous material occurrences on a site. This ESA is intended to reduce, but not eliminate, uncertainty regarding the potential for recognized environmental conditions in connection with the subject properties.

1.2 Involved Parties

GS Lyon Consultants, Inc. has been retained by 85JP 8ME, LLC to conduct a Phase I ESA at the subject properties as a prerequisite to property transaction (lease). The owners of the properties are:

2.0 SCOPE OF WORK

2.1 Site Reconnaissance

A site reconnaissance was performed by Randy Lyon, a staff environmental technician of GS Lyon Consultants on May 8, 2013. The reconnaissance included visual observations of surficial conditions at the sites and observation of adjoining properties to the extent that they were visible from public areas. The reconnaissance also included site observations for the presence of polychlorinated biphenyls (PCB's) and/or asbestos containing materials (ACM's), indications of surface or subsurface hydrocarbon or pesticide contamination, the presence of on-site groundwater wells, pits or sumps, wastewater discharge practices, and surface water drainage patterns. The observations made are presented in Sections 3.1 through 3.6 of this report. Photo-documentation of the site conditions observed during the site reconnaissance is provided in Appendix A.

2.2 Background Review

A review of historic topographic maps (Appendix B), historic aerial photographs (Appendix C), and historic telephone and Polk City directories was performed to evaluate potentially adverse environmental conditions resulting from previous ownership and uses of the sites. The details of the review are presented in Sections 4.1 through 4.6 of this report.

2.3 Regulatory Review

GS Lyon Consultants contracted Environmental Data Resources, Inc. (EDR) of Southport, Connecticut to generate a compilation of State and Federal regulatory lists containing information regarding hazardous materials occurrences on or within a one mile radius of the subject sites. The EDR report is included in Appendix D. The details of the review are presented in Section 5.0 of this report.

2.4 Review of Title Documents/Environmental Liens

Preliminary title documents were not provided by the client for review; therefore, no search for environmental liens was performed for the subject properties.

2.5 Analysis and Report Preparation

GS Lyon Consultants has reviewed the information outlined above and made inquiries of pertinent agencies regarding information gathered and general information about the sites. This report summarizes the results of our study and provides our professional opinions regarding Recognized Environmental Concerns (REC's) on the sites from past usage of the sites and/or potential offsite sources and is presented in Section 6.0 of this report.

Historical data was obtained for the subject sites dating back to 1949. The historical data, consisting of aerial photographs, historical telephone directories, Polk City Directories, was relatively complete. Any data gaps that were encountered while conducting research for the report would not affect the ability to identify recognized environmental conditions on the subject sites because of the undeveloped (agricultural fields) nature of the subject site.

2.6 User Questionnaire

User questionnaires were provided to each property owner to aid in gathering information that may be pertinent to the evaluation of the subject parcels for environmental conditions. The completed user questionnaires are provided in Appendix E.

3.0 SITE OVERVIEW

3.1 Site Location

The subject sites are located at the northwest corner of State Route 98 and Weed Road (APN 059-050-002, 003 and 001) west of Calexico, California. The sites locations are depicted on Plate 1, Vicinity Map.

3.2 Site Description

Topographic maps (USGS 7.5 minute Heber, CA Quadrangles) indicate that the elevations of the properties are approximately 5-7 feet below mean sea level (MSL) throughout the site (Elevation 992-990 local datum). The Imperial Irrigation District (IID), which supplies power and raw (irrigation) water to the area, established local datum by equating mean sea level to El. 1000.00 feet.

The subject site is comprised of seven (7) agricultural fields currently in crop production. The subject site is separated into three (3) ownership sections (see Site Map, Appendix B). There are two rural residences in the northwest corner of ownership section 3. An old farm worker labor camp (Bracero program) was located along the eastern boundary of the site in the central portion of ownership section 1. The labor camp is now used as an area to stage farming equipment during crop cultivation and harvesting of the adjacent fields. No hazardous chemicals were noted at the 2 rural residences or old farm labor camp. A propane tank is located at the old farm labor camp.

Photographs of the sites taken on May 8, 2013 during our site reconnaissance visit are included in Appendix A.

3.3 Adjacent Properties

The sites are located at the northwest corner of State Route 98 and Weed Road west of Calexico, California. Properties surrounding the subject site are agricultural fields. There is a rural residence adjacent to the north of the northwest corner of ownership section 3 (Ferrell Road). The New River is adjacent to the northern boundary of the site. An abandoned cattle feed yard is located north of the subject site across the New River. PV solar power generation facilities are being built to the south, southwest and west of the site across State Route 98 and Ferrell Road.

3.4 Geologic Setting

The sites are located in the Colorado Desert Physiographic province of southern California. The dominant feature of the Colorado Desert province is the Salton Trough, a geologic structural depression resulting from large-scale regional faulting. The trough is bounded on the northeast by the San Andreas Fault and the southwest by faults of the San Jacinto Fault Zone. The Salton Trough represents northward extension of the Gulf of California, which has experienced continual in-filling with both marine and non-marine sediments since the Miocene Epoch (25 million years before present). The tectonic activity that formed the trough continues at a high rate as evidenced by deformed young sedimentary deposits and high levels of historic seismicity.

The sites are directly underlain by Holocene (0-11,000 years before present) Cahuilla Lake sediments, which consist of interbedded lenticular and tabular sand, silt, and clay. The predominant surface soil is silty clay. The Holocene lake deposits are considered to be less than 100 feet thick and are characterized by surficial clay and silt deposits with varying amounts of fine sand. The topography of the Imperial Valley is relatively flat, with few significant land features. The valley floor slopes gently to the north (less than 0.5 percent) from an elevation of sea level at Calexico to approximately 225 feet below sea level at the Salton Sea.

3.5 Soil Conditions

The U. S. Soil Conservation Service compiled a map of surface soil conditions based on a thirteen-year study from 1962-1975. The Soil Survey maps were published in 1981 and indicate that surficial deposits at the sites and surrounding area consist predominantly of silty clay loams of the Imperial, Glenbar and Holtville soil groups (see Plate 3 and soil descriptions in Appendix B). These loams are formed in sediment and alluvium of mixed origin (Colorado River overflows and fresh-water lake-bed sediments). Based on Unified Soil Classification System presented in the Soils Survey Report, the permeability of these soils is expected to be low. The northern area of the site near the New River consist of sandy soils of the Meloland, Indio and Vent soils ground. The permeability of these soils is expected to be moderate.

3.6 Groundwater Conditions

The groundwater in the area of the subject properties is brackish, not used for beneficial purposes and is encountered at a depth of 6-8 feet below the ground surface. Depth to groundwater may fluctuate due to localized geologic conditions, precipitation, irrigation, drainage and construction practices in the region. Based on the regional topography, groundwater flow is assumed to be generally towards the north within the site area. Flow directions may also vary locally in the vicinity of the sites.

4.0 SITE HISTORY AND OPERATIONS

4.1 Historical Aerial Photo Review

Aerial photographs from the Imperial Irrigation District (IID) archives dating back to 1949 were reviewed for historical development of the subject site. Reproductions of the historical aerial photographs reviewed are included in Appendix C.

The 1949, 1972 and 1984 aerial photographs show the site as agricultural fields in production, which is the same as present day. The two (2) rural residences in the northwest corner of ownership section 3 (along Ferrell Road) and the old farm labor camp along the eastern boundary ownership section 1 (along Weed Road) are present from 1949 to present day.

4.2 Sanborn Fire Insurance Map Review

Sanborn Fire Insurance Maps are large scale maps depicting the commercial, industrial, and residential sections of various cities across the United States. Since the primary use of the fire insurance maps was to assess the buildings that were being insured, the existence and location of fuel storage tanks, flammable or other potentially toxic substances, and the nature of businesses are often shown on these maps.

Due to the rural undeveloped nature of the site and vicinity, Sanborn Fire Insurance Maps do not cover the subject properties.

4.3 Review of Historic Topographic Maps

Historic topographic maps, USGS 7.5 Min. Heber, CA Quadrangles, showed the labor camp located along the eastern boundary of the site in the central portion of ownership section 1.

4.4 Review of Historic Telephone and Polk Directories

Telephone Directories: Telephone directories for the Imperial County, which included the City of Calexico businesses published in 1941, 1955, 1965, 1974, 1994, and 2004 were reviewed. No service stations, chemical manufacturers, petroleum manufacturers, distributors, or automotive repair facilities were noted at the sites.

Polk City Directories: City directories are used for locating individuals and businesses in a particular urban or suburban area. City directories are generally divided into three sections: a business index, a list of resident names and addresses, the name and type of businesses (if unclear from the name). While city directory coverage is comprehensive for major cities, it may be spotty for rural and small towns. The Polk City Directories for the years 1963 and 1984 were reviewed.

The subject sites are not covered by the Polk Directories due to their rural nature.

4.5 Agency Interviews

The local Department of Toxic Substances Control Imperial Certified Unified Program Agency (DTSC Imperial CUPA) office was contacted (Veronica Lopez) on May 7, 2013. No records for the subject site were found that would lead to possible RECs associated with the subject site.

4.6 Other Information

Wetlands: The New River is adjacent to the northern boundary of the subject site.

Sewer/water: Irrigation water is supplied by the Imperial Irrigation District via gravity flow canals for the agricultural fields at the subject site. The rural residences and abandoned labor camp utilize septic systems (septic tanks and leach fields) to dispose of waste water at the site.

Building Construction Materials: There is a potential risk of asbestos containing materials (ACM) and lead based paint existing at the subject site due to the age of the building at the abandoned labor camp (post 1949). The two rural residences in the northwest corner of ownership section 3 are new mobile homes (post 1978) and are unlikely to have lead paint or asbestos products in the building materials.

Seismic Faults: The nearest seismic faults (Superstition Hills Fault/Laguna Salada Fault/Imperial Fault) are located about 9 miles north, south and east of the sites. Strong ground shaking can be expected for magnitudes of 6.0 to 7.2 events on these faults. The recurrence interval for 6.0 magnitude or greater events on the Imperial Fault is 29 years.

Airport Zone: The eastern site is located about 2.5 miles west of the departure end of the Calexico International Airport (General Aviation Traffic Only and light commercial jets/prop jets). The subject sites are not located within an Airport Compatibility Zone.

Industrial Areas: An agricultural pesticide applicator (Frontier Ag Service) is located 0.5 mile south of the southern site boundary.

Agricultural Practices: Typical agricultural practices in the Imperial Valley consist of aerial and ground application of pesticides and application of chemical fertilizers to both ground and irrigation water. Many agricultural fields are burned after crop removal (wheat stubble, asparagus, etc.). Typical concentrations of DDT and DDE pesticides in the soil are about 25% to 50% of regulatory action levels. Many agricultural fields are burned after crop removal (wheat stubble, asparagus, etc.).

The U.S. Geologic Survey, at the request of the Imperial Irrigation District (IID), performed a "one-time" water quality study of 27 irrigation drains throughout the Imperial Valley during the summer of 1994. Review of the study results indicate that the drains sampled contained less than the regulatory limits of arsenic, selenium, and nitrites for drinking water.

5.0 REGULATORY RECORDS REVIEW

5.1 Review of Government Records Search

The following is a brief synopsis of sites identified in the Environmental Data Resources (EDR) report. The report is included in its entirety in Appendix D.

A review of the EDR report, along with the listed orphan sites, did not identify any sites located within 1 mile as potential risks to the subject site. The sites listed in the report do not present recognized environmental concerns associated with the subject site, due to their distance from the site (1/2 mile) and clay soils (low permeability) at and surrounding the subject site. Therefore, transport of hazardous chemicals to the subject site is not likely.

6.0 DISCUSSION AND CONCLUSIONS

We have performed a Phase I Environmental Site Assessment in general conformance with the scope and limitations of ASTM E1527-05 at the subject sites located at the northwest corner of State Route 98 and Weed Road west of Calexico, California. Any exceptions to, or deletions from, this practice are described in Section 2.0 of this report. **This assessment has not revealed any Recognized Environmental Conditions (REC's) for the study sites.**

7.0 LIMITATIONS

The data presented and the opinions expressed in this report are qualified as follows:

- Our assessment of the sites and surrounding areas was conducted in accordance with ASTM guidelines and the *generally accepted environmental engineering standard of*

practice which existed in Imperial County, California at the time that the report was prepared. No warranty, express or implied, is made.

- The sole purpose of the investigation and of this report is to assess the physical characteristics of the sites with respect to the presence or absence in the environment of oil or hazardous materials and substances as defined in the applicable state and federal environmental laws and regulations and to gather information regarding current and past usages that may result in adverse environmental conditions at the sites.
- GS Lyon Consultants, Inc. derived the data in this report primarily from visual inspections, examination of public records and information in the public domain, informal interviews with individuals, and readily available information about the sites. The passage of time, manifestation of latent conditions or occurrence of future events may require further exploration of the site, analysis of the data, and reevaluation of the findings, observations, and conclusions expressed in the report.

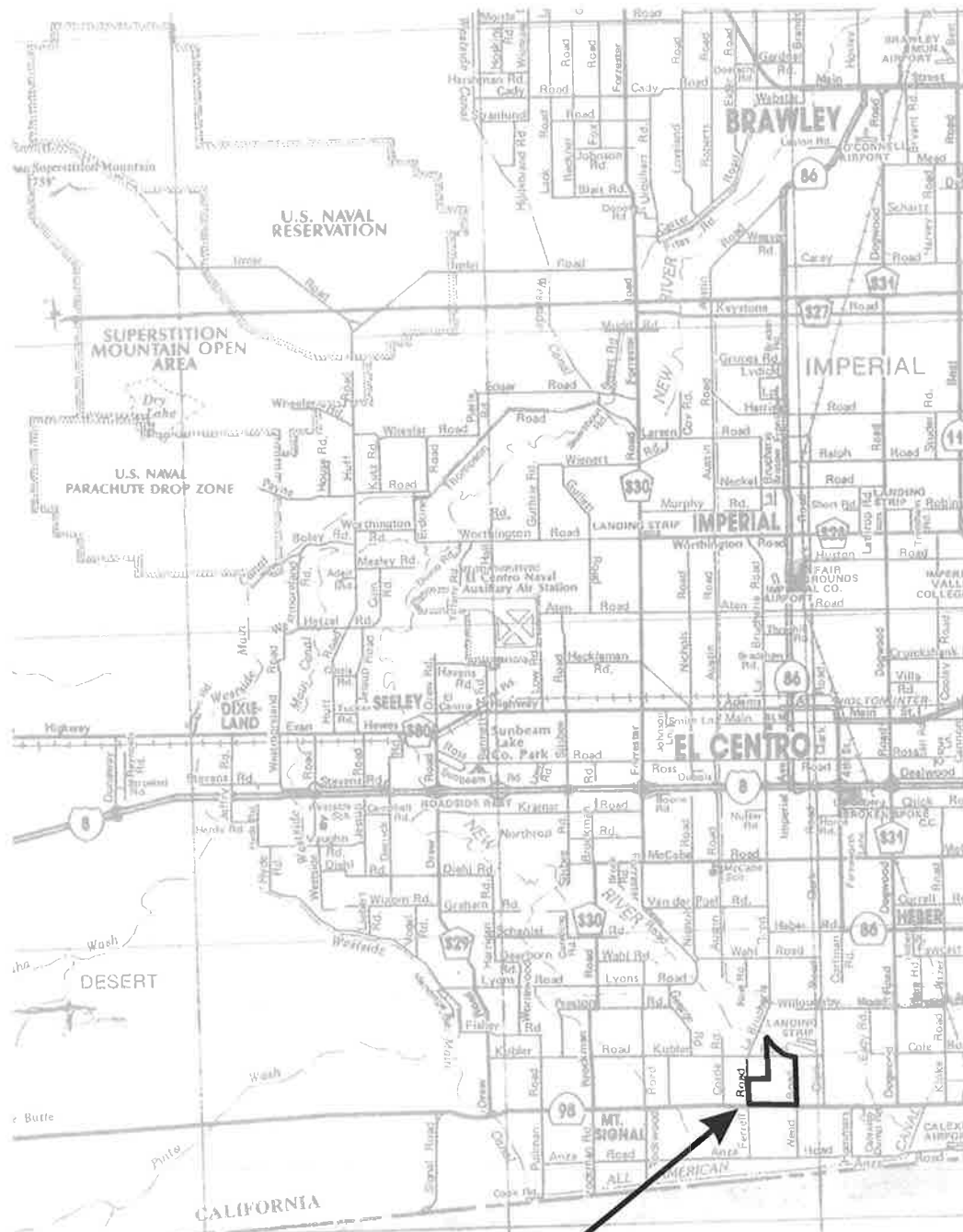

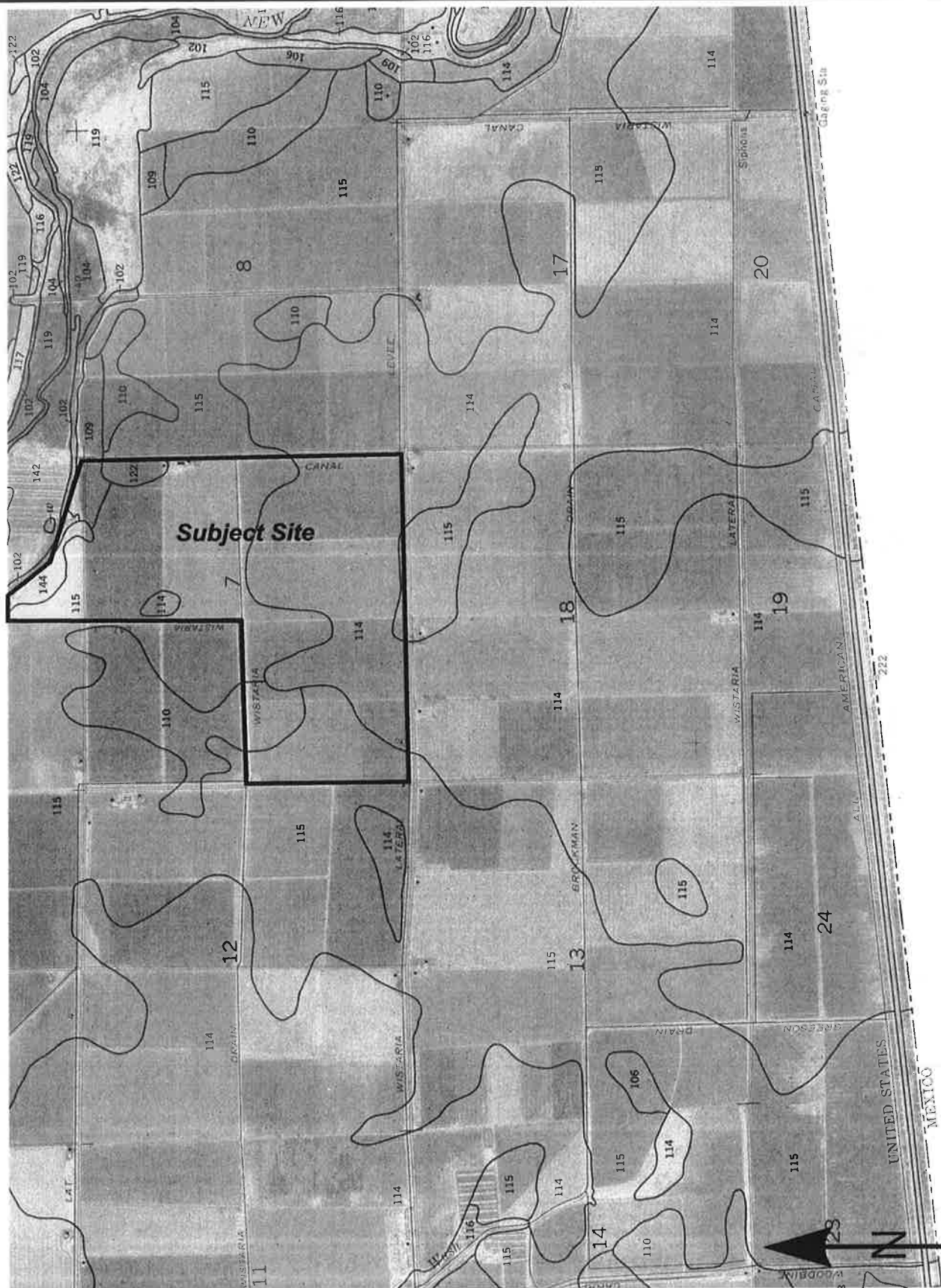

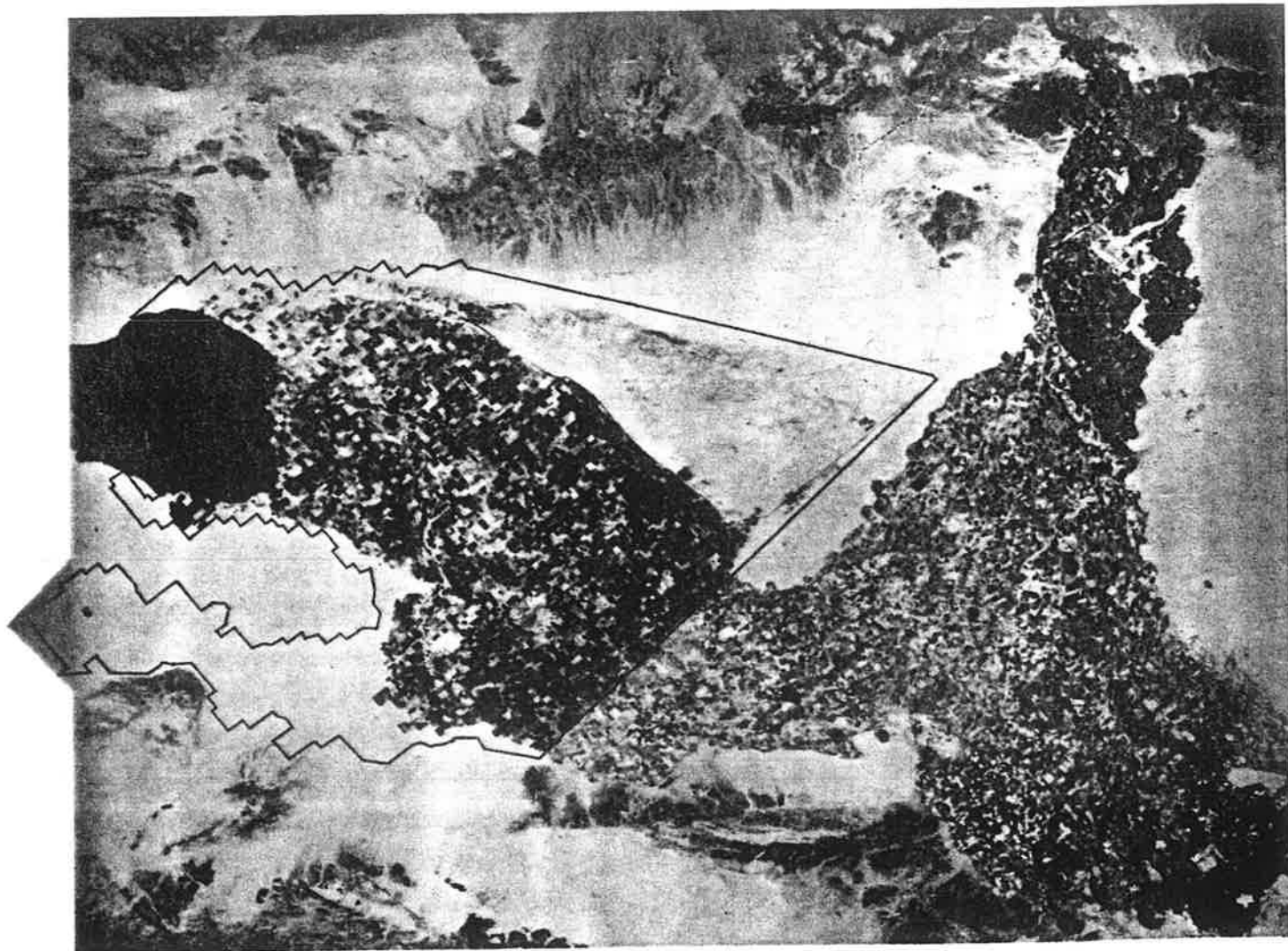
