

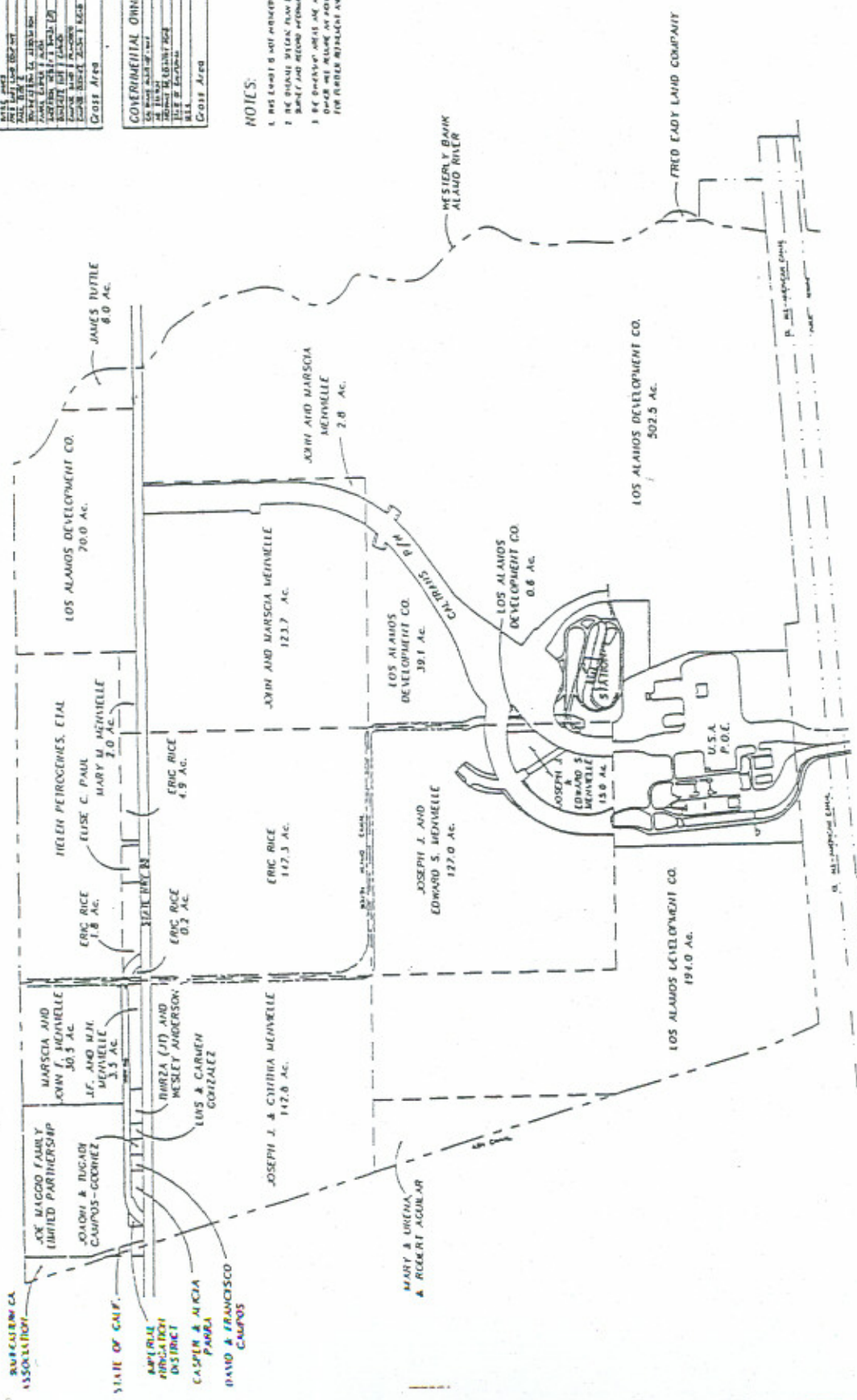

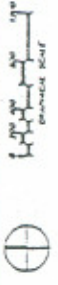

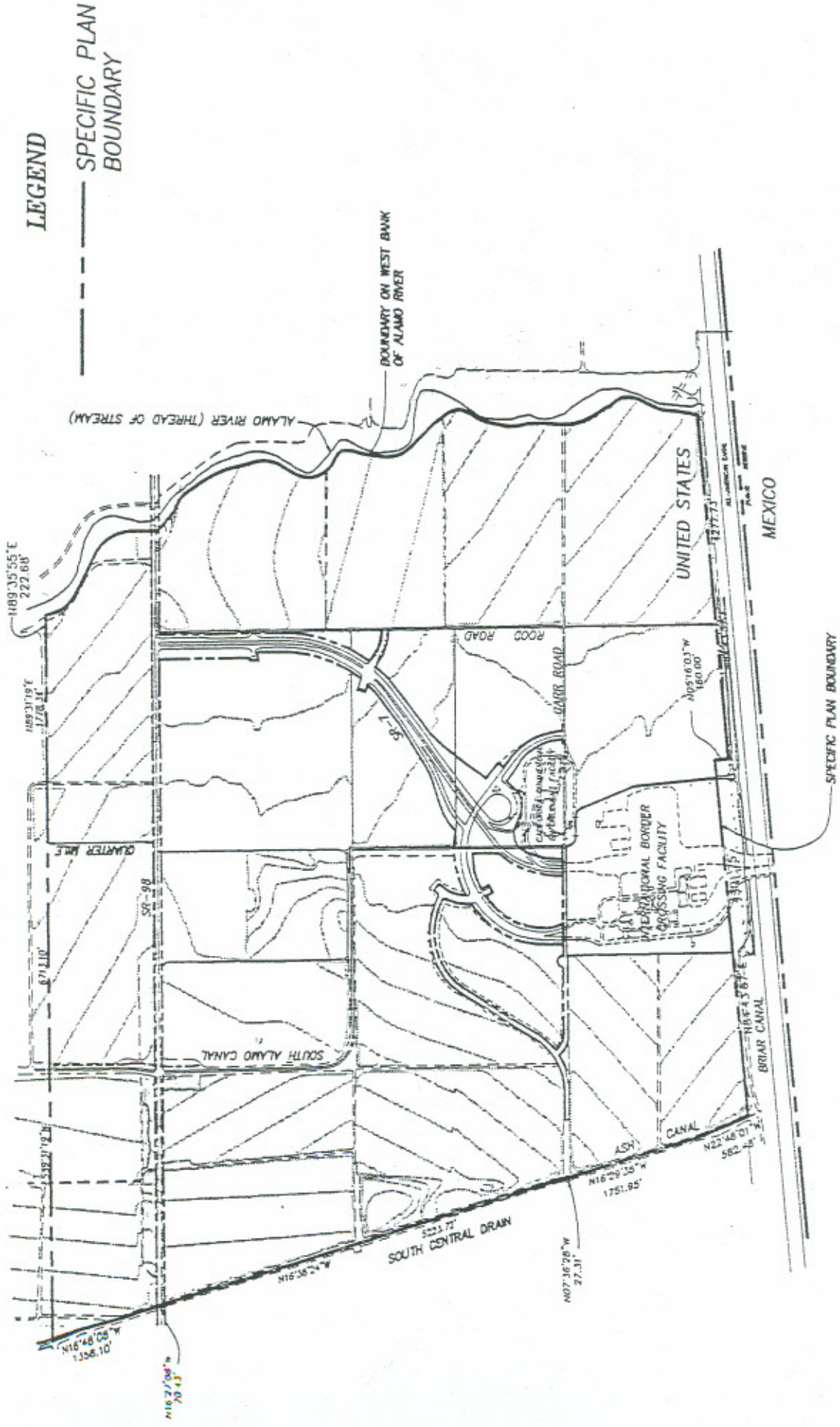
EAST BORDER CROSSING
